1. Scope

All data subjects whose personal data is collected, in line with the requirements of the GDPR.

2. Responsibilities

- 2.1 The GDPR Owner is responsible for ensuring that this notice is made available to data subjects prior to Chester Running Tours collecting/processing their personal data.
- 2.2 All Employees/Staff of Chester Running Tours who interact with data subjects are responsible for ensuring that this notice is drawn to the data subject's attention and their consent to the processing of their data is secured.

Any legitimate interests pursued by us, or third parties we use, are as follows:

- Re-marketing of future tours and events to customers whom have previously attended.

No special categories of personal data are processed.

3.3 **Consent**

By consenting to this privacy notice you are giving us permission to process your personal data specifically for the purposes identified.

Consent is required for Chester Running Tours to process both types of personal data, but it must be explicitly given. If we are asking you for sensitive personal data we will always tell you why and how the information will be used.

3.4 **Disclosure**

Chester Running Tours *will not* pass on your personal data to third parties *without first obtaining your consent*

3.5 **Retention period**

Chester Running Tours will process personal data for up to 3 weeks post tour event and will store the personal data for a max of 6 years.

3.6 **Your rights as a data subject**

At any point while we are in possession of or processing your personal data, you, the data subject, have the following rights:

- Right of access – you have the right to request a copy of the information that we hold about you.
- Right of rectification – you have a right to correct data that we hold about you that is inaccurate or incomplete.
- Right to be forgotten – in certain circumstances you can ask for the data we hold about you to be erased from our records.
- Right to restriction of processing – where certain conditions apply to have a right to restrict the processing.
- Right of portability – you have the right to have the data we hold about you transferred to another organisation.
- Right to object – you have the right to object to certain types of processing such as direct marketing.
- Right to object to automated processing, including profiling – you also have the right to be subject to the legal effects of automated processing or profiling.

- Right to judicial review: in the event that Chester Running Tours refuses your request under rights of access, we will provide you with a reason as to why. You have the right to complain as outlined in clause 3.6 below.

3.7 **Complaints**

In the event that you wish to make a complaint about how your personal data is being processed by Chester Running Tours (or third parties as described in 3.4 above), or how your complaint has been handled, you have the right to lodge a complaint directly with the supervisory authority and Chester Running Tours's GDPR Owner.
